

# **Application for Incardination/Ordination**

## **General Instructions**

This application is for clergy who wish to incardinate into the Catholic Episcopal Church from other jurisdictions as part of their intent to become Deacons, Priests or Bishops. Individuals wishing to incardinate must have prior pastoral experience and must have already been ordained or consecrated. Individuals who have not already been sacramentally ordained or consecrated must submit to instruction and ordination as part of the process of incardination.

This application is also used for individuals in discernment of a vocation to Holy Orders. In some cases when differing theology may exist, retraining and instruction is required.

Information requested in this application will be kept confidential. All information submitted with this application will be verified independently, so please be detailed in providing dates and locations and all other relevant information. Any material misstatement of fact shall be considered deliberate, and shall be grounds for rejection of this application. This application in no way guarantees or provides and promise to the recipient of successfully being incardinated.
